## SECTION 3.02 DEFINITION OF SPECIFIC TERMS AND WORDS

Electronic Gaming Operation: Any business establishment, whether as a principal or accessory use, where persons utilize electronic machines, including but not limited to computers and gaming terminals, to conduct games of skill or chance, including but not limited to sweepstakes, where cash, merchandise or other items of value are redeemed or otherwise distributed, whether or not the value of such distribution is determined by electronic games played or by predetermined odds. This does not include any lottery approved by the State of North Carolina, any nonprofit operation that is otherwise lawful under state law, such as church or civic fundraisers, or "Recreation Establishments" as defined in this chapter.

Recreation Establishment: An establishment designed for the conduct of sports and leisure time activities including but not limited to video, table, and other related games, as well as instructional programs. However, there shall be no alcoholic beverages served or allowed upon such premises. Recreation establishments shall not include "Electronic Gaming Operations" as defined in this chapter, nor shall they include any other use which requires an adult only area.
